

# Privacy policy

Should you visit <https://www.ganteline.hu/en> and get in touch with GANTELINÉ Munkavédelmi Ruházatot Forgalmazó Kereskedelmi és Szolgáltató Korlátolt Felelősségű Társaság (hereinafter: „GANTELINÉ” or „Data controller”) or register yourself, it will become necessary to process your personal data.

1. When do we process your personal data?

1.1. When you get in touch with us on our website

Why do we process your data?

We process your data because you contacted GANTELINÉ via our website or by electronic means.

What is the basis of processing your data?

GANTELINÉ processes your data on the basis of your consent.

Are you obliged to provide your data?

You are not obliged to provide your data. Should you not provide your data, unfortunately we will not be able to get in touch with you.

What categories of data do we process?

Your name, email address, and the content of your message.

For how long do we keep your data?

We keep the data you provided for communicational purposes until you revoke your consent regarding data processing.

To whom do we forward your personal data?

Should you have a query as an end user (or as the representative of an end user), we forward your contact details to our distributor partner so that they will be able to get in touch with you.

1.2 Registration on our website (user account)

Why do we process your data?

We process your data because you subscribed to our service when we create a user account

for you and you will have access to our complete product range on our website.

What is the basis of processing your data?

GANTELINE processes your data on the basis of your consent.

Are you obliged to provide your data?

You are not obliged to provide your data. Should you not provide your data, we will not be able to create your user account and you will not have access to our complete product range.

What categories of data do we process?

Your name, email address, and phone number.

For how long do we keep your data?

We keep the data you provided until you revoke your consent regarding data processing.

To whom do we forward your personal data?

We do not forward your data to third parties.

2. What kind of rights do you have regarding the data processing conducted by GANTELINE?

Accessibility

You may ask a feedback from us at any time whether the processing of your personal data is in progress. You may ask questions about the purpose of the data processing, what categories of personal data do we process, to whom do we forward your data and for how long do we process the data.

Rectification

You may ask us to rectify your personal data and to supplement incomplete data we have on our records.

Restriction

You may ask the restriction of the processing of your personal data from GANTELINE if

You contest the accuracy of the personal data, for a period enabling GANTELINE to verify the accuracy of the personal data,

the data processing is unlawful and you oppose the erasure of personal data,

GANTELINE does not need the personal data anymore, however, you need them for establishing, exercising or defending legal claims,

You objected to processing, pending the verification whether the legitimate grounds of GANTELINE override those of yours.

Objection

You may object to the processing of your personal data at any time, should the ground of the data processing be in the legitimate interest of GANTELINE. For further information please see the section “What is the basis of processing your data” of this policy.

Erasure

You may ask us to erase your personal data if

the personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed,

the withdraw consent on which the processing is based and there is no other legal ground for the processing,

You object to the processing and there are no overriding legitimate grounds for the processing,

the personal data have been unlawfully processed.

#### Complaints

Should you experience any malpractice with regards to our data processing practices, you may submit your complaint to the National Authority for Data Protection and Freedom of Information (1125 Budapest, Szilágyi Erzsébet fasor 22/C.; <https://naih.hu/>). Furthermore, you are also entitled to contact the court to enforce your rights.
